

Privacy Policy

At Words of a Feather, we are committed to ensuring the privacy of your personal information. #### Information we collect

For each visitor to our website, our site analytics collects the following type of information for statistical purposes:

- The number of users who visit the website
- The date and time of visits
- The number of pages viewed
- Traffic patterns

This is anonymous statistical data. No attempt will be made to identify users or their browsing activities. We use this data to evaluate our website performance and improve our content and online offerings.

# **Providing Information**

When you provide us with personal details (i.e. when completing a contact form or enrolment form), we will request personal information such as your name, address, e-mail address and a contact phone number. This information is important so we may contact you when necessary on issues relating directly to our service.

We will not use your personal information for any purpose that is not related to the services we provide to you or for any purpose for which you would not reasonably expect us to use the information, unless you have consented to the information being put to another related use, or would reasonably expect that the information would be put to another related use. We will never sell or disclose your information to any individual or entity outside Words of a Feather for marketing purposes.
